On December 23, 2016, the Petitioner filed a *Petition for Judicial Review* in the above-captioned matter. *Notices of Appearance* were subsequently filed by the South Valley Ground Water District, McCain Foods USA, Inc., A&B Irrigation District, Burley Irrigation District, Milner Irrigation District, North Side Canal Company, Twin Falls Canal Company, American Falls Reservoir District #2, Minidoka Irrigation District, City of Pocatello, City of Bliss, City of Buhl, City of Burley, City of Carey, City of Declo, City of Dietrich, City of Gooding, City of Hazelton, City of Heyburn, City of Jerome, City of Paul, City of Richfield, City of Rupert, City of Wendell, City of Hailey, and the Idaho Ground Water Appropriators, Inc. Pursuant to the *Procedural Order* issued by the Court, the *Notices of Appearance* will be treated as *Motions to Intervene*. The Court finds that the *Motions to Intervene* are unopposed, as no party has objected to the movants participating in this proceeding. This Court thus finds that the movants are real parties in interest to this proceeding and have interests that could be affected by the outcome of this proceeding. Therefore, in exercising its discretion, this Court finds that the movants are entitled to leave to intervene as parties to this proceeding.

On January 20, 2017, the Water District 37B Groundwater Association filed a *Verified Petition to Intervene* in this matter pursuant to Idaho Appellate Rule 7.1. The Court finds that the Water District 37B Groundwater Association has interests that could be affected by the outcome of this proceeding. Therefore, in exercising its discretion, the Court finds that the Water District 37B Groundwater Association is entitled to leave to intervene as a party to this proceeding.

THEREFORE THE FOLLOWING ARE HEREBY ORDERED:

- 1. The *Motions to Intervene* filed in the above-captioned proceeding are hereby granted. Likewise, the *Petition to Intervene* filed by the Water District 37B Groundwater Association is hereby granted.
- 2. All further captions used in this proceeding shall include the movants as Intervenors as shown above.
- 3. All further service in this case shall be in accordance with the Certificate of Service attached hereto.
